Gunnar Gouras gives the following update to the Board regarding the innovation / administration of MultiPark:

- Pia Berntsson: Grant Manager (50% MultiPark (2015) whereof 25% SIA during Jan-Jun 2015)
- Diana Jerman: Research Administrator (50% MultiPark 2015)
- Ulrika Mundt-Petersén: Project administrator (20% MultiPark; Jan-Jun 2015)
- Jens Persson: Information officer (25% MultiPark 2015)

It was **decided** to apply the following conditions for infrastructures receiving funds for the call based on the strategic plan:

- 1) All MultiPark scientists should be able to use all infrastructures
- 2) MultiPark and the Principal Investigator for the infrastructure must agree on an user fee
- 3) Plan on how many that should be able to use infrastructure

No formal declaration of "conflict of interest" was made during the meeting, but each translational group composition with names was clearly stated during the presentation of the translational groups.
