§1. Meeting starts

Gunnar Gouras opens the meeting. Johan Jakobsson (not attending: vicecoordinator of BAGADILICO) and Susanna Lindvall (attending via phone; vicepresident of European Parkinson's Disease Association (EPDA)) were invited as adjunct members for this board meeting. The adjunct members have no right to vote.

§2. Declaration of conflict of interest

Several board members have a conflict of interest to specific parts of budget items in §8 II, IV-V and it was declared for each decision in §8 II, IV-V.

§3. Designation of the "Justeringsperson"

Arne Lindgren is assigned together with the Chair to approve the minutes.

§4. Approval of the agenda

The Board approves the agenda.

§5. Minutes from latest Board meeting March 21st 2017 (enclosure 1)

The Board approves the board minutes from the latest board meeting March 21st 2017.

§6. Delegated decisions (enclosure 2)

The travel grants that have been approved since the last board meeting by the Coordinator and Vice Coordinator are summarized in the table in enclosure 2.

§7. Information

a. Management update, including graduate school, innovation, centre process, infrastructure (enclosure 3)

Anna-Karin Ekman (50%) will replace Diana Jerman from June 1st. Oskar Hansson informed that the centre application has been submitted on May 23rd and a presentation was done for the ALF committee by Oskar Hansson on June 1st.

Preparatory course in Neuroscience will be scheduled to Autumn 2018. The new innovation officer (Simon Jegou) is now participating in the MultiPark innovation meetings.

Infrastructure group has now been established – clinical representative is pending at the moment and the group will work on organizing the MultiPark supported infrastructure. A draft for general guidelines on MultiPark funded infrastructures (enclosure 3) was discussed. It was suggested to edit and review the document in the infrastructure group and present a new version at next board meeting.

Specifically it was suggested to clarify some points and add the following:

- Acknowledge MultiPark supported infrastructure in publications and presentations – add suggested text on MultiPark infrastructure website in publications
- Add to the last bullet point in the text draft: "There is no guarantee that support will be given in the future"
- Indicate that "All users must pay user fees"
- Add rules, such as how many users per research group that can be added as users
- What are the consequences when, for example, a PhD student is using an infrastructure for which funding ends
- Indicate the single researcher (owner) who is responsible for specific instrument
- The suggestion was made to obtain feedback on infrastructures from the MultiPark users

§8. Decision

- a) Budget item 2017 (enclosure 4)
- I. Neurology Parkinson register resource request (enclosure 4A) It was decided to delegate the decision to the Chair person to approve a modified application, with the request to make the revised text more understandable to external board members. This new request considers reallocation of funds originally approved in the budget for a research doctor that subsequently could not be used and after a previous request to the board had been extended into 2018. Also it should be specified that this position will be as adjunct faculty employed by Region Skåne rather than as guest professor, which would have required faculty approval.

- П., **Neuroimaging – investment in PET imaging (enclosure 4B)** It was **decided** to approve the application and reallocate already permitted funding from the approved sum 5.881.376 SEK (incl. overhead) for PET scanning to instead strengthen the Cyclotron Unit for neuro-PET with equipment and materials for radiochemicals with 4.856,000 SEK (incl. overhead).
 - Two synthesisers modules in total 3,399,200 SEK (incl. overhead)
 - HPLC-system 971,200 SEK (incl. overhead)
 - Material for production single cassettes, HPLC columns, enriched H₂¹⁸O water for production of ¹⁸F 485,600 SEK (incl. overhead) The surplus of 1,025,376 SEK (including overhead) will be returned to the general budget of Multipark and can be used for other purpose.

Oskar Hansson had a conflict of interest as user of neuroimaging and did not take part in the decision and left the meeting room during the discussion and decision.

- III. Cell and gene therapy – reallocation of resources (enclosure 4C) It was **decided** to support the reallocation of funds from the budget from Multipark to the two groups during 2017, mainly from sequencing infrastructure funding. The sum 120,900 SEK (incl. overhead) will be allocated to cover 25% of the researcher engineer salary during 6 months at the Amperometry infrastructure (closing down in September 2017) to cover salary costs normally covered by the user fees.
- IV. Biobank – request additional resources (enclosure 4D) It was **decided** NOT to support this new request from the biobank. Oskar Hansson and Itzia Jimenez had a conflict of interest as user and as PhD student to Maria Swanberg of the resource, respectively, and did not take part in the decision. The board viewed this request not as a reallocation of already granted funds as I to III above, but as a new request for funds.

٧. PhD Call decision

It was **decided** to support 2 applications in the PhD Call with salary support for 50% during 4 years for PhD students in the groups of Angela Cenci-Nilsson and Tomas Deierborg, as decided by the reviewers. The external board members reviewed the applications prior to the board meeting and the decision was made prior to the meeting by the participating external board members in a review meeting separate from the actual board meeting.

Gunnar Gouras, Oskar Hansson and Roger Olsson had a conflict of interest as co-applicants and did not take part in the decision.

§9. Other issues

Per Odin presented an update about the ongoing research in his research group - Restorative Parkinson Unit - before the actual meeting.

The senior lecturer position at health science will not be engaged until late this year or early 2018. The health science has therefore requested to use applied

funds for 2017 (780,000 SEK) allocated to this item during 2017. The board *decided* NOT to approve the request.

It was suggested that any surplus from the Multipark budget 2017, after halfyear review of the budget, can be used for additional calls decided at the next board meeting during the early autumn.

Any enclosures sent to the board should be clearly written and with sufficient background to enable the external board members to be able to make informed decisions.

The Chair declared the end of the meeting.
